Suggestion: Read through first then apply

- 1) After your visit the doctor,
- 2) (and after the doctor deems that medical marijuana is appropriate),
- 3) and after the risks and benefits are explained,
- 4) and the consents are reviewed and signed
- 5)we will register you with the state.

When this registration is complete: you will get **two** emails from the state.

The first email will be with your patient identification number,

the second, and more important email will be one with a temporary password.

What you will need before you apply

- 1) You need to be registered
- 2) You will need your registered email address
- 3) You will need your temporary password
- 4) Paper and or pen
- 5) You will need a **picture** of your face (no glasses or hat, white background)
- 6) You will need a **picture** of your driver's licence
- 7) A check or money order for \$75
- 8) A lot of patience
